### **PRIVACY AND COOKIES POLICY**

We at FunDancing (formerly known as Slimdance-Babergh) (“we” or “our” or “us”) want to make sure all the personal information we have collected about you, is safe and secure whether we collect it through our website at **www.fundancing.co.uk** (“Site”) or from other sources. This Policy set outs our commitments to you, in compliance with and beyond the General Data Protection Regulation (commonly known as the **GDPR**) and explains how we collect, store and use your personal information.

We have not appointed a Data Protection Officer to oversee our compliance with data protection laws as we are not required to do so, but Janet Drake has overall responsibility for data protection compliance in our organisation. If you have any questions about this Policy or what we do with your personal information, their contact details are set out in the “**Contact**” section below.

#### **PRIVACY NOTICES**

Collecting specific, relevant personal information is a necessary part of us being able to provide you with any services you may request from us or in providing services to our customers and members or just managing our relationship with you.

When we hold or use your personal information we will provide you with access to a privacy notice, which sets out in detail what information we hold about you (such as your contact details, address, etc.), how your personal information may be used and the reasons for these uses, together with details of your rights.

Where we collect personal information from you directly, we will provide access to this privacy notice at the time we collect the personal information from you. Where we receive your personal information indirectly, we will provide access to this privacy notice when we first contact you, first pass the data to someone else or within a month, whichever is the earlier.

We will only provide access to this privacy notice to you once, generally at the start of our relationship with you. However if the applicable privacy notice is updated substantially, then we may provide you with details of the updated version. You are encouraged to check back regularly for updates.

#### **HOW DO WE USE YOUR PERSONAL INFORMATION?**

We will use your personal information as described in the privacy notice provided to you, but, for example, we may use your personal information to administer any account(s) you have with us or to send you information we think you might find useful, provided you have indicated that you are happy to be contacted for these purposes. #### **WHO DO WE SHARE YOUR PERSONAL INFORMATION WITH?**

Details of how we disclose your personal information are set out in the relevant privacy notice provided to you, but generally it is where we need to do so in order to run our organisation (e.g. where other people process information for us). In such circumstances, we will put in place arrangements to protect your personal information. Outside of that we do not disclose your personal information unless we are required to do so by law.

If we transfer personal information about you outside the European Economic Area (EEA), we will let you know and ensure that all reasonable security measures are taken and that any third party processors will be required to process the information in accordance with information protection laws and we will notify you in your privacy notice if we are the information controller.

We do not sell, trade or rent your personal information to others.

#### **HOW LONG DO WE HOLD ON TO YOUR PERSONAL INFORMATION?**

Further details of how long we hold onto your personal information for are set out in the relevant privacy notice, but we will only hold your information for as long as is necessary or where you ask us to delete records we may delete it earlier.

The duration for which we retain your personal information will differ depending on the type of information and the reason why it was collected. However, in some cases personal information may be retained on a long term basis: for example, personal information that we need to retain for legal purposes will normally be retained for at least six years in accordance with usual commercial practice and regulatory requirements.

#### **WHAT ARE YOUR RIGHTS?**

Unfortunately, no information transmission over the Internet is guaranteed 100% secure nor is any storage of information always 100% secure, but we do take all appropriate steps to protect the security of your personal information.

#### **COOKIES AND LOG FILES**

Cookies are used to help you in your interactions with the site. Most cookies are session cookies, lasting only for the duration of your visit and are deleted when you close your browser. No personally identifiable data is collected. Examples of the sort of information that is collected via session cookies are provided below. This list is not exhaustive:

- The last search term that you used within the site
- Your preference in terms of accessible viewing options
- A unique ID to track your session from page to page, which is vitally important should you sign into the site
- Which page you are looking at within a multi-paged index of content, or search results.

This site uses 1&1 SiteAnalytics to allow us to track how popular our site is and to record visitor trends over time. 1&1 SiteAnalytics uses a cookie to help track which pages are accessed. The cookie contains no personally identifiable information, but it does use your computer's IP address to determine where in the world you are accessing the site from, to track your page visits within the site.
